

September 13, 2022 Minutes

The Coffee County Legislative Body met September 13, 2022 in a regular scheduled meeting at the Coffee County Administrative Plaza at 6:00 PM.

Sheriff Chad Partin proclaimed the meeting open for business.

Pastor Ron Fuller gave the Invocation and Boy Scout Troop 314 of Manchester led the Pledge to the Flag.

There were 17 members present for the meeting with Benny Jones being absent.

County Clerk, Teresa McFadden requested nominations for Commission Chairman. Nomination by Tim Brown to elect Mayor Judd Matheny as Chairman. There being no other nominations a motion was requested. Motion made by Deford and seconded by Hollandsworth to elect Judd Matheny as Chairman. The motion was approved with 17 yes votes.

Mayor Matheny assumed the duties as Commission Chairman. Mayor Matheny then requested nominations for Commission Chairman Pro Tempore. Tim Morris nominated Tim Stubblefield and Tim Brown nominated Dennis Hunt. Motion made by Tim Morris and seconded by Duncan for nominations to cease and call for a vote. The motion was approved with 16 yes votes and Hunt abstained. Upon roll call Tim Stubblefield received 9 votes and Hunt received 6 votes. Voting for Hunt were Hollandsworth, Hobbs, Morse, Nettles, Smith and Tim Brown. Voting for Tim Stubblefield were Hodge, DeFord, Tim Morris, Hershman, Reed, Duncan, Miller, Sebourn and Watkins. Hunt and Stubblefield abstained.

Mayor Matheny amended the agenda by striking number 3 under item 12 a. Motion made by Stubblefield and seconded by Morse to approve the agenda as amended. The motion was approved with 17 yes votes.

Motion made by Sebourn and seconded by Hollandsworth to approve the minutes of the previous meeting. The motion was approved with 17 yes votes.
